## **Cathedral of St. Raymond School Chromebook Program**

The Cathedral of St. Raymond School Chromebook Program is designed to use technology for academic purposes at St. Raymond School. The students are assigned a Chromebook, which is a Chrome web browser device created by Google. This device works in conjunction with the school-issued Google Accounts, giving access to Google Drive, Google Apps, and a wide range of third-party educational sites.

### **Parent/Guardian Technology Agreement**

Each new family is required to carefully read this Chromebook Handbook together, discuss it, and take a Google Form quiz with a score of 100%. Families can retake the quiz until they get 100%.

Both the parent/guardian and the student must sign the CSRN Student/Parent Technology Agreement and return it to school. Once the signed agreement is received and the Google Form quiz is passed at 100%, the student can take the Chromebook home. The Agreement is due on Sept. 8, 2025.

### **Parent/Guardian Expectations and Responsibilities**

Payment agreements for Chromebooks must be kept current. The full cost of the Chromebooks are purchased up front minus one dollar. You will have the option to complete the purchase of the Chromebook and gain ownership upon graduating or leaving the school. Until that point, the Chromebook remains the property of St. Raymond School.

Throughout the time their student participates in the Cathedral of St. Raymond School Chromebook Program, parents/guardians have a responsibility to supervise their child's use of the Chromebook, Internet use at home, and care of the Chromebook. If there is any physical damage to the Chromebook as a result of misuse or lack of care, families will be held financially responsible for the cost to repair the Chromebook, just as they would for lost or damaged textbooks. While you and your child are responsible for the Chromebook, accidental damage is sometimes unavoidable.

### **Student Expectations and Responsibilities: Students are expected to do the following:**

- **Charge the Chromebook overnight at home and bring Chromebook fully charged every day. The charging port is on the left side of the Chromebook.**
- Take the Chromebook home every afternoon and complete all homework assignments.
- Carry the Chromebook in the issued protective case. Students will use their Chromebook at school every day and will have homework assignments that require the use of the Chromebook.
- Use the avatar created in class as a profile picture. This is the only option for a profile picture.

### **Caring for the Chromebook**

1. **Nothing should be affixed** (attached, glued, taped, stuck on) to the Chromebook's plastic shell or screen or on the provided Chromebook case. An exception is made for the Student of the Week sticker which can be put on Chromebooks. All stickers that come affixed on Chromebooks, including bar codes and name labels, must remain on the Chromebooks. If the label with the student's name comes off, tell the Technology Teacher right away so that it can be replaced.
2. **Keep all liquids and food items away from your Chromebook.** Liquids and food crumbs can damage the Chromebook.
3. **Always have clean hands before using your Chromebook.** Clean hands make it easier to use your Chromebook touchpad and there will be less risk of leaving dirt and other stains on the computer.

4. **Keep your Chromebook clean.**
  - a. Turn off the Chromebook before cleaning the touch screen.
  - b. **Touch screen:** Use a dry, soft, and lint-free cloth or a piece of absorbent cotton to remove fingerprints or dust from the touch screen. **Do not apply solvents to the cloth.** The touch screen is a glass panel covered with a plastic film. Do not apply pressure or place any metallic object on the screen.
  - c. **Keyboard:** Canned air or small computer-specific vacuum cleaners are an excellent way to clean keyboards, computer case vents, or around disk drive openings.
5. **Protect the touch screen.** Keep sharp objects from the screen. When you shut your Chromebook, make sure there are no small items such as a pencil or small earbuds on the keyboard. Use the pocket on the outside of the carrying case for pens or pencils. **The screen can crack or break easily even if it is protected in a carrying case. Never throw or drop your carrying case on the ground!** Close the lid gently from the middle. Closing the lid using only one side causes pressure on that hinge and over time can cause it to bend and break.
6. **Carry the Chromebook closed**, not by its screen. If you lift it by the screen alone, you could damage the display or the hinges attaching it to the base.
7. **Don't pull on the power cord.** To unplug from an outlet, pull the plug with your fingers rather than yanking the cord. Beware of tripping over the cord, causing the Chromebook to fall to the floor. Lost or damaged power cords are the responsibility of the family.
8. **The power cord plugs into the left side of the Chromebook. Make sure the light comes on so you know it's charging.**
  - a. Make sure the outlet you use is not on a wall switch that turns the outlet off when you turn off the light switch.
9. **Store your Chromebook in your Chromebook bag.** Do not sit, throw, or step on your backpack with your Chromebook in it. Ultimately, you are responsible for anything that happens to your Chromebook.
10. **Don't leave your Chromebook in a car.** A Chromebook is an inviting target for someone to break into your car and steal it. Your Chromebook should be kept in a safe location that is dry and cool in temperature.
11. **Do not leave the Chromebook on the floor at school or at home.**
12. **Protect your identity.** Students should not put their email or personal information online. Beware of PHISHING sites. These are fake websites made to look like other popular sites. When you log into these fake sites, they steal your login information and can access your accounts.
13. **Social media sites. Social media sites require that students be at least 13 years old to create an account. Students may not use social media, including Spotify, on school devices.** The Chromebooks are for educational purposes.

## Terms of Use

### Distribution, Collection, and Management

Chromebooks are property of the Cathedral of St. Raymond School and are loaned to students for the duration of their junior high years at St. Raymond. Chromebooks should only be used by the student it is assigned to. Chromebooks cannot be lent to others, not even brothers or sisters.

Chromebooks are subject to inspection at any time without notice and remain the property of the Cathedral of St. Raymond School until the finalization of its purchase at the end of eighth grade or upon

withdrawing from the school.

Chromebooks will be collected and stored at school during the summer months and redistributed at the beginning of the next school year.

At the end of the 8th grade year, if all previous Chromebook payment agreements have been completed and tuition payments are current, families will have the option to complete the purchase of the Chromebook for \$1 or have the option of donating it to the school for use by younger students.

In choosing to finish purchasing your child's Chromebook, you agree to purchase the Chromebook as-is and accept full responsibility for future repairs or system failures. Safety restrictions and filtering will be the responsibility of the family after the student leaves the school.

### **Revoking Use of Chromebook**

Because the Chromebooks are the property of the Cathedral of St. Raymond School, the school has the right to revoke Chromebook privileges if there are repeated office referrals/suspensions or misuse of the Chromebook or improper internet use, etc.

### **Loss or Theft**

Chromebooks that are lost or stolen as a result of student or parent negligence will not be replaced, and students may have to complete their work without the use of a Chromebook. Chromebook replacement due to loss or theft will be determined by the school on a case-by-case basis.

**Lost or stolen Chromebooks must be reported immediately to St. Raymond School.** Following the report of theft of a Chromebook, the student will be asked to provide a statement describing the circumstance to the school administration who will contact the police to file a report. If the Chromebook is recovered and returned to the school, it will be reassigned to the student. The cost of replacing the Chromebook, if it is not returned, will be the responsibility of the family. The Chromebook needs to be replaced in a timely manner.

### **Warranty**

Chromebooks come with a 1-year manufacturer warranty. A three-year accidental/manufacture defect warranty has been purchased for each Chromebook. Repairs not covered by a warranty need to be completed in a timely manner.

### **Repairs / Technical Support**

If a Chromebook needs repair, students must report the issue to the Technology Teacher. If a loaner Chromebook is available, students will use the loaner until the student's Chromebook is repaired. Repairs take about six weeks once the Chromebook is shipped.

### **Student Google Accounts**

Chromebooks are managed and associated with the Cathedral of St. Raymond Google Apps domain. Each student's Google Account is *username@csrn.org* which serves as the device login and security. This username and password is extremely important in protecting the student's privacy and files.

**Students must not share any password with other students:** Students should report any password security leak to the Technology Teacher who can reset the password.

Students are required to be logged into their Google account any time that the Chromebook is in use. Browsing as a guest is strictly prohibited.

### **Responsible Use/Internet Safety Policy**

Chromebooks are provided to enable students to access educational resources and enrichment activities and to equip students with the skills they need to be successful.

Students are prohibited from accessing, sharing, or creating inappropriate or graphic content, including images or language depicting violence, nudity, pornography, obscenity or otherwise unsuitable subject matter. The Cathedral of St. Raymond School filters Internet activity to restrict access to inappropriate online content; however, no filtering program is entirely effective, and ultimate responsibility lies with the student and his or her family.

Students are further prohibited from using chat and instant messaging services and social networking sites. Finally, students must comply with the Acceptable Use Agreement for the Diocese of Joliet.

During the school day, student Chromebook use will be monitored by staff, in person and online, for both educational and safety purposes. We use Securly to filter and monitor student use of Chromebooks to keep them safe. Attempting to get around this monitoring in any way could result in disciplinary action including losing Chromebook privileges.

Students are prohibited from "wiping" a Chromebook or attempting to clear the browser history.

### **Privacy Policy**

Chromebooks and the school network are property of the Cathedral of St. Raymond School. Any information that is accessed or transmitted through the school network on a Chromebook belonging to Cathedral of St. Raymond School may be monitored, viewed, cataloged, or deleted by the school staff.

St. Raymond School further reserves the right to investigate suspected inappropriate computer conduct by students and their families and will fully cooperate with local, state, and federal law enforcement officials in the event of unlawful misconduct or suspicion of misconduct.

### **Desktop Wallpaper and Customizing New Tabs**

Images and photos should not depict violence, nudity, pornography, graphic language, offensive material, illegal activity, or gang activity. Gifs are not permitted.

Photos of St. Raymond students may be used on wallpaper or tabs only if the students in the photos give permission and the photo is appropriate. Cameras can only be used with the permission of the teacher.

### **Network Etiquette (Email, Commenting, etc.)**

All electronic communication is subject to monitoring and should not be considered confidential.

Students are expected to use proper grammar, spelling, and punctuation in all electronic communication and should use professional, respectful language. Students are not to use inappropriate content, including text or images depicting violence, nudity, pornography, graphic language, or illegal activity. Further, parents and students should be respectful of teachers' time and should not email teachers for reasons that are not school-related. They should follow Diocesan school policies.

### **Plagiarism**

Plagiarism is the act of taking someone else's words, images, or ideas and presenting them as one's own. Technology such as a Chromebook makes it easy to copy and paste information from the Internet into a student assignment. However, taking information directly from an existing source without citing the source is plagiarism, and it is academic dishonesty. Students should read information from sources, think about what they read, and then write in their own words. They must properly cite where the information came from. Students may use **short** quotations if they give the citation. If a student is unsure about what constitutes plagiarism, he or she should talk with a teacher or another school staff member. Students found plagiarizing will lose credit for their assignment and may face additional disciplinary actions.

### **Headphones/Earbuds**

Students need to have headphones or earbuds with them every day at school. Wired headphones or earbuds that plug in are the best since they don't need to be charged. **Headphones/earbuds may be used at school only when directed by or with permission from the teacher.**

### **Artificial Intelligence: AI**

At St. Raymond School, we recognize that new technologies, including Artificial Intelligence (AI), are becoming part of everyday life and learning. While AI can be a helpful tool, it must be used responsibly, ethically, and in a way that supports student learning and growth.

### **Expectations for Students:**

**Honesty in Work:** All assignments, tests, and projects must reflect a student's own understanding. Using AI to generate answers or complete work without teacher permission is considered cheating.

**Learning First:** AI may be used as a tool for brainstorming, practice, or support ONLY when a teacher has given clear directions. Students should never rely on AI in place of their own effort or creativity.

**Respect and Responsibility:** Students are expected to use technology, including AI, in a way that is safe, appropriate, and respectful of Catholic values. AI should never be used to produce harmful, inappropriate, or disrespectful content.

### **Expectations for Parents:**

- Support your child in understanding that AI is a tool for learning, not a shortcut.
- Encourage discussions at home about honesty, integrity, and responsible use of technology.

### **Consequences:**

If a student uses AI in a way that violates this policy or a teacher's directions, the work will not be accepted. The student will receive an automatic zero on their work, be required to redo the assignment honestly\*, during lunch and parents will be contacted. Depending on the nature of the offense, the student may also be required to serve a detention or a suspension.

\*Even though the student received a zero grade, he/she will be required to complete the work for the sake of his/her own academic progress.

### **Our Goal:**

We want students to grow as critical thinkers, problem solvers, and creators who use technology responsibly and in line with our Catholic mission to seek truth and act with integrity.

### **Chromebook Cases**

Chromebook cases are issued by the school. This is the only case the student should use in transporting the device to and from school. Nothing can be altered or personalized on the case. A name card will be issued with the case. Cases should be used only for the storage of the Chromebook. Pencils, power cords, and other small items should be put in the zippered pouch on the outside of the case.

### **Camera and Microphone**

Use of the camera and microphone are strictly prohibited during school unless permission is granted by the classroom teacher. Students should use good judgment when using the camera and microphone. The camera will not be used to take inappropriate, illicit, or sexually explicit photos or videos, nor will it be used to embarrass anyone in any way. Photographs of another student, staff member, family member, or even a stranger can only be taken with that person's permission.

**Printing**

Students can print at home from their Chromebooks. Before printing at school, students must have permission from a teacher. Printing to the school printer must be for a school assignment in which the teacher directs the student to print.

**Disciplinary Actions**

Failure to follow the rules and guidelines presented in this handbook will result in disciplinary action and criminal prosecution, if appropriate. This includes, but is not limited to, tampering with the Chromebook's administrative settings, neglecting, or stealing the school-issued Chromebook, etc. Depending on the violation, disciplinary actions are to be determined by the Cathedral of St. Raymond administration and may include parent contact, loss of assignment credit, detention, in or out-of-school suspension, and temporary or permanent loss of Chromebook privileges. Students will be required to complete their work without the use of a school-issued Chromebook.

**Right to Amend**

The Cathedral of Saint Raymond School reserves the right to modify the 1 to 1 Chromebook program and/or the terms of this handbook at any time.

- Not leave my Chromebook unattended in the hallways, on the floor, or in campus buildings.

I am able to do the following:

- Use the Chromebook to help organize myself and my studies.

I understand my **family's** responsibilities include:

- Protecting the Chromebook, within reason, against damage, loss, or theft while ensuring the Chromebook is cared for as outlined in the Chromebook Handbook.
- Ensuring my child's Chromebook is carried in the school issued carrying case in order to prevent damage to the device.

- Ensuring my child has adequate opportunities to use the Chromebook and Google Apps for Education at home to complete school assignments.

I understand my **family's** fiscal responsibility as part the CSRN Initiative includes:
